

# THE CORPORATION OF THE TOWN OF KINGSVILLE

## BY-LAW 18 - 2019

---

### Being a By-law respecting remuneration and expenses for Members of Council and Local Boards

**WHEREAS** section 283(1) of the *Municipal Act, 2001* S.O. 2001 c. 25, as amended, (the “Act”) provides that a municipality may pay any part of the remuneration and expenses of Council members, members of any local board and their employees.

**AND WHEREAS** sections 283(2) and (3) of the Act provides that a municipality may only pay the expenses of the member of its Council, a local board, or of their officers and employees if the expenses are actually incurred or are, in the opinion of Council or the local board, a reasonable estimate of the actual expenses that would be incurred.

**AND WHEREAS** The Corporation of the Town of Kingsville (the “Town”) deems it advisable to pay remuneration and expenses of members of its Council and local boards.

**AND WHEREAS** the Town deems it advisable to repeal By-law 29-2015 and all amendments thereto, including, but not limited to By-law 60-2015.

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF KINGSVILLE ENACTS AS FOLLOWS:**

#### Definitions

1. In this By-law and in the Schedules attached, the following definitions shall apply:
  - a) “local board” has the same meaning as set out in section 1 of the Act; and
  - b) “ex-officio member” means a member of a local board of the Town who, by statute or by by-law, is entitled to be a member of that local board by virtue of his or her office as head of Council.

#### Remuneration

2. Council members shall receive remuneration in accordance with Schedule “A” appended to and forming part of this By-law.
3. Except as otherwise indicated in Schedule “B”, a person appointed by Council to a local board, whether such person is a Council member or otherwise, or any ex-officio member, shall receive remuneration in accordance with Schedule “B” appended to and forming part of this By-law.

#### Expenses

4. The expenses of the members of Council or local board shall be paid in accordance with:
  - a) section 283(2) of the Act; and
  - b) any Town policy in place from time to time that provides for the payment of expenses of members of Council, local boards, committees and/or officers and employees.

**Repeal, Effective Date and Coming into Force**

5. That By-law 29-2015 and all amendments thereto, including, but not limited to By-law 60-2015 is hereby repealed.
6. The provisions of this By-law shall be effective commencing on the 1<sup>st</sup> day of January, 2019.
7. This By-Law comes into force and takes effect on the day of the final passing thereof.

## **SCHEDULE "A"**

### **Remuneration of Council Members**

#### **1. Remuneration**

Annual remuneration as follows:

Mayor	\$37,329.59
Deputy Mayor	\$25,161.83
Councillor	\$20,527.23

Remuneration shall be adjusted annually based upon the Consumer Price Index.

#### **2. Method of Payment**

Payment of remuneration shall be by way of monthly installments.

## SCHEDULE "B"

### Remuneration of Members of Local Boards of the Town

#### 1. Remuneration

- a) In respect of the following local boards, annual remuneration as set out below:

<b>Local Board</b>	<b>Remuneration</b>
• Committee of Adjustment (including any Property Standards Committee meetings)	\$2,094.24
• Police Services Board	\$2,094.24
• Union Water Supply System	\$2,908.68

- b) In respect of the following local boards, remuneration in the amount of \$100.00 per meeting, conditional upon the attendance by the member at the meeting, to a maximum of 12 meetings per year:

- Compliance Audit Committee (no maximum number of annual meetings)
- Court of Revision (to neighbouring municipality)
- Erie Shores Transportation Committee
- Fantasy of Lights Festival Committee
- Fence Viewers
- Kingsville Accessibility Advisory Committee
- Kingsville Business Improvement Association\*\*
- Kingsville Historical Park
- Kingsville Leamington Municipal Animal Control Advisory Committee (Joint Animal Control)
- Kingsville Municipal Heritage Advisory Committee
- Kingsville Parks, Recreation and Culture Committee
- Kingsville Port Management
- Kingsville Tourism and Economic Development Committee
- Migration Community Hall Board of Directors
- Migration Festival Committee
- Pelee Island Transportation Services Advisory Committee
- Personnel Committee
- Planning Advisory Committee

\*\*Remuneration shall be paid to Council members and ex-officio members only.

- c) In respect of persons appointed as Alternates to any local boards, remuneration shall be in the amount of \$100.00 per meeting, conditional upon the attendance by the member at the meeting.

#### 2. Method of Payment

Payment of remuneration shall be made quarterly.
