



Q2 What type of road do you live on?





Q3 Where are sidewalks located on your road?





Q4 How often do you use sidewalks in residential areas?





Q5 If you don't have a sidewalk along your property, would you support the installation of one?





Q6 If a sidewalk was proposed to be constructed on your street with no end destination, would you support this construction?







Q8 Does your sidewalk make you feel more safe or less safe in your neighborhood?




