Tenders for the above noted project were received electronically by the Corporation of the Town of Kingsville on their Bids and Tenders Website and closed at 11:00 a.m. on Tuesday, July 6th, 2021. A total of four (4) tenders were received for the project. We have conducted a detailed review of all four (4) tenders and offer the following summary:

1.	D'Amore Construction (2000) Ltd.	\$2,570,223.00	30	65
2.	Sterling Ridge Infrastructure Inc.	\$2,723,325.00	45	90

4.	J & J Lepera Infrastructures Inc.	\$2,977,000.00	42	54

All four (4) Contractors have provided a Bid Bond in the amount of 10% of the Tender Price.

The lowest tender received was submitted by D'Amore Construction (2000) Ltd. (D'Amore) for the amount of \$2,570,223.00 (excluding H.S.T). We have reviewed the Tender from D'Amore and found it to have one mathematical error, they left tender item number 53 in Part E for the Bridge and Drain Works blank. We clarified with the Contractor that this is because their precast supplier will not require shear plates as the total amount of cover is sufficient to not require them. It is therefore a zero dollar item. This is satisfactory pending verification by the precast supplier provided shop drawings.

The Contractors start date and number of working days are satisfactory.

After reviewing the tender, and with D'Amore submitting the lowest bid, together with their previous experience with projects of this type, we would recommend that the Corporation of the Town of Kingsville award this Tender to D'Amore Construction (2000) Ltd. in the amount of \$2,570,223.00 plus H.S.T. for a total tender price of **\$2,904,351.99**.

We trust that the above provides the Town with the information that they require at this time. Should there be any questions regarding same please do not hesitate to contact us. We look forward to working with the Town to carry out the construction of this project once they have established a Contractor for the works.
