This office has reviewed the above-mentioned report, which has been submitted to this ministry as a condition of licensing in accordance with Part VI of the *Ontario Heritage Act*, R.S.O. 1990, c 0.18.¹ This review has been carried out in order to determine whether the licensed professional consultant archaeologist has met the terms and conditions of their licence, that the licensee assessed the property and documented archaeological resources using a process that accords with the 2011 *Standards and Guidelines for Consultant Archaeologists* set by the ministry, and that the archaeological fieldwork and report recommendations are consistent with the conservation, protection and preservation of the cultural heritage of Ontario.

The report documents the assessment/mitigation of the study area as depicted in "Map 8: Stage 1-2 AA results" of the above titled report and recommends the following:

Considering the findings outlined within this report, the following recommendations are presented:

1. The Malott H1 (AaHq-28) site does not represent a significant archaeological resource and it has no further cultural heritage value or interest. It is recommended that this site within the project area limits be cleared of any further archaeological concerns.
2. The study area is considered free of archaeological concern. No further work is recommended.

No construction activities shall take place within the study area prior to the MHSTCI (Archaeology Programs Unit) confirming in writing that all archaeological licensing and technical review requirements have been satisfied.

Based on the information contained in the report, the ministry is satisfied that the fieldwork and reporting for the archaeological assessment are consistent with the ministry's 2011 *Standards and Guidelines for Consultant Archaeologists* and the terms and conditions for archaeological licences. This report has been entered into the Ontario Public Register of Archaeological Reports.
