The following is provided as a result of our review of Zoning By-Law Amendment ZBA-03-21. The applicants are looking to construct an addition in front of the attached garage and convert the addition and existing garage into a secondary dwelling unit for their elderly parents. The current zoning of the property permits a single family dwelling and accessory structures. A site-specific zoning amendment is proposed to permit the second dwelling unit, as per *Section 2.10* of the Official Plan for a property not on full servicing, where the subject property is on private septic. The applicants have provided an approved septic analysis for the proposed secondary dwelling unit.
