Purpose

The purpose of this report is to provide an update to the safety inquiry adjacent to Gosfield North School on County Road 27 in the Municipality of Lakeshore.

Background

At the County Council meeting of April 7, 2021, the report <u>Traffic Calming</u> <u>Gosfield North Public School</u> was presented to Council for information.

CR 27 is a 2-lane rural arterial road with narrow lane widths of 3.5m. The road also includes a 2.0m gravel shoulder on both sides. Gosfield North school is not located in a community or built-up environment and has two access locations from CR 27.

Discussion

Infrastructure Services Department (ISD) staff completed a review of the roadway characteristics that consider measurables such as daily traffic volume, vehicle operating speed, pedestrian volumes, collision history, and the presence (or lack of) multi-modal amenities to determine areas that would benefit from being designated as a community safety zone or school safety zone.

More recent discussions with the School Principal indicate that there are observed concerns regarding the speed of vehicles and a speed reduction could support on-site efforts to manage traffic. This finding was supported by the technical review carried out by staff.

It is recommended to upgrade the school area signs with school zone signs with an associated reduction in posted speed from 80kph to 60 kph in operation Monday to Friday 7.00am to 5.00 pm. Road markings to enhance the school zone area will also be implemented. The intent of safety zone is to provide road users with visual awareness that they should be diligent in their attentiveness to roadway safety when traveling in or through designated areas. A location plan showing the signs and markings is attached in Appendix A.

Financial Implications

The cost to enhance the signage and road marking are included in the 2021 ISD budget.

Recommendation

That Essex County Council adopt By-Law number 2021-26 to amend By-law 26-2002 (A by-law to regulate traffic and parking on highways within the Essex County Roads System), designating a school zone on a portion of CR 27, in the Town of Kingsville.
