BY-LAW 81-2021

Being a By-law to amend By-law No. 1-2014, the Comprehensive Zoning By-law for the Town of Kingsville

WHEREAS By-law No. 1-2014 is the Town's Comprehensive Zoning By-law to regulate the use of land and the character, location and use of buildings and structures in the Town of Kingsville;

AND WHEREAS the Council of the Corporation of the Town of Kingsville deems it expedient and in the best interest of proper planning to further amend By-law No. 1-2014 as herein provided;

AND WHEREAS there is an Official Plan in effect in the Town of Kingsville and this By-law is deemed to be in conformity with the Town of Kingsville Official Plan;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF KINGSVILLE ENACTS AS FOLLOWS:

1. That Subsection 8.6 (e) RURAL COMMERCIAL (C6) EXCEPTIONS is amended with the addition of the following new subsection:

8.6.14 'RURAL COMMERCIAL EXCEPTION 14 (C6-14)'

For lands shown as C6-14 on Map 56 on Schedule "A" of this By-law.

- a) Permitted Uses
 - i) Veterinary Clinic
 - ii) Personal Service Shop
 - iii) Farm Produce Outlet
- b) Permitted Buildings and Structures
 - i) Buildings and structures for the permitted uses
 - ii) Buildings and structures accessory to the permitted uses.
- c) Zone Provisions
 - i) All lot and building requirements for the permitted buildings and structures shall be as existing on the date of passing of this By-
- 2. Schedule "A", Map 56 of By-law 1-2014 is hereby amended by changing the zone symbol on lands known municipally as 1172 County Road 20, Part Lot 10, Con S 4 WD, as shown on Schedule 'A' in cross-hatch attached hereto from 'Education (EG)' to 'Rural Commercial Exception 14 (C6-14)'.

3. This by-law shall come into force upon third reading and being finally passed.
