#### A. CALL TO ORDER

Deputy Mayor Queen called the Regular Meeting to order at 6:00 p.m. with all members present except Councillor Neufeld who was absent on personal business.

## D. LAND ACKNOWLEDGEMENT

Deputy Mayor Queen read the following Land Acknowledgement Statement:

We acknowledge the Three Fires Confederacy (Ojibwe, Potawatomie and Odawa) and the Traditional ancestral, unceded territory of Caldwell First Nation; the original people of Point Pelee, Pelee Island and its surrounding waters. We recognize and respect the First Nations who are stewards of the land and waters of Turtle Island and who have embraced this stewardship since time immemorial. We would like to acknowledge other nearby First Nations Communities and First Nations across Turtle Island.

# Boarding, Lodging and Rooming Houses - Official Plan and Zoning By-law Amendments

The Director of Community and Development Services provided an overview of his Report through a PowerPoint presentation.

Deputy Mayor Queen then brought forward Delegation 2.a. Chief Commissioner Patricia DeGuire, Ontario Human Rights Commission.

# 2. DELEGATIONS

# a. Chief Commissioner Patricia DeGuire, Ontario Human Rights Commission

Chief Commissioner Patricia DeGuire, participating electronically, addressed Council. She thanked Council for receiving the correspondences from the Ontario Human Rights Commission dated June 24 and August 30, 2022, referenced said correspondences in her presentation, and is encouraging Council to pass the Official Plan Amendments and Zoning By-law Amendments as acceptable first steps in this process.

#### b. Laura Mastronardi, Sunrise Farms

Laura Mastronardi on behalf of Sunrise Farms presented her written submission, indicating her concerns that the proposed Official Plan and Zoning By-law Amendments is "far over reaching on the part of the municipality". She provided a list of onsite employment and some directly related small businesses who service the agricultural sector, which list was also provided with her written submission.

#### c. Taneeta Doma, on behalf of Justicia/Justice for Migrant Workers

Taneeta Doma, participating electronically, stated that she is a staff lawyer with The Migrant Farm Worker Clinic at the University of Windsor's Faculty of Law. She stated that on behalf of a group of individuals associated with the clinic and with the Justice for Migrant Workers collective they do support the amendments as they exist on paper, but have concerns regarding aspects of the process and future implementation. She raised concerns that the amendments did not include meaningful and ongoing consultation with migrant workers, and commented on the importance of farm workers living in residential areas, with access to resources.

#### d. Chris Ramsaroop

Chris Ramsaroop, participating electronically, indicated he has spoken to thousands of migrant workers and expressed concerns that the workers were not consulted in regard to the proposed by-law amendments; he stated that the workers are the foundation of the agricultural sector but are excluded from decisions. He detailed specific concerns in regard to the proposed amendments and licensing scheme, and requested that the workers be added as key stakeholders. He asked for enforcement mechanisms to protect workers and not punish workers.

# e. Elizabeth Ha, Member of Justice for Migrant Workers and an Equity Vice-President for the Ontario Federation of Labour.

Ms. Ha, attending in person, indicated she has spoken to workers and has seen the living conditions they experience. She appreciates that while consultation meetings were held, the workers may not understand what the by-laws entail. She asked that a process be put in place to provide protection for workers if they provide complaints about their living conditions.

# f. Aaron Coristine, Ontario Greenhouse Vegetable Growers

Mr. Coristine stated that there has been a lot of work done since June, however, as a sector, the OGVG feel there is still room for further collaboration. He requested clarification on the proposed housing registry and licensing to avoid redundancies with Provincial legislation and Federal legislation. He asked that Council delay a decision just a little further and continue the collaboration between the sector and the community with new criteria to establish a new path forward that the greenhouse sector can champion for many municipalities going forward.

There were no further delegations.

The Town Clerk introduced the report and recommendation.
