

# POLICE SERVICES BOARD MEETING WEDNESDAY, SEPTEMBER 28, 2022 @ 4:00 P.M. Council Chambers 2021 Division Road North, Kingsville, Ontario N9Y 2Y9

### A. CALL TO ORDER

Vice Chair Chisholm called the Meeting to order at 4:01 p.m. with the following persons in attendance:

#### **B. ELECTION OF CHAIR**

Vice Chair Chisholm informed that Kingsville Council, at its Regular Meeting held on August 8, 2022, decided to leave the Police Services Board seat formerly occupied by Nelson Santos (who had acted as Chair) vacant for the remainder of the 2018-2022 Council term.

He stated that it would be in order to call for nominations for the Chair position.

Ms. DeYong nominated William Chisholm as Chair.

Mr. Wilson nominated William Chisholm as Chair.

Ms. Kitchen asked if there were any further or other nominations. There being no further nominations, Mr. Chisholm accepted the nomination by acclamation to act as Chair of the Police Services Board for the remainder of the 2018-2022 Council term.

### H. NEW AND UNFINISHED BUSINESS

1. 4-way stop at intersection of County Road 34 and County Road 27 in Cottam



Chair Chisholm thanked the officers for patrolling and monitoring the new 4-way stop sign that has been installed at the intersection of County Roads 34 and 27.

- 3. Chair Chisholm advised that at its Regular Meeting held 2022 09 12 Kingsville Council passed the following motion:

WHEREAS there have been ongoing complaints about the use of Lions Park:

AND WHEREAS these concerns have continued to escalate to unacceptable levels;

AND WHEREAS efforts to date by the Town and OPP to curb these issues have been unsuccessful;

THEREFORE BE IT RESOLVED that Administration be directed to prepare a report outlining immediate actions that can be taken to ensure all residents can safely enjoy their property, along with a request to the Police Services Board for a report from the OPP detailing the complaints that have been received and their response to such complaints, both reports to be presented to Council by the end of 2022."

Details in regard to the Lions Park concerns will come back to the October 26, 2022 Police Services Board meeting for further discussion and review.

- 4. Constable Silvano provided the following updates:
  - i) An officer has been recently transferred to the Kingsville Detachment, who is motorcycle trained. The motorcycle is now stored in Kingsville, the citizens will see more OPP motorcycle parol and traffic enforcement conducted in the area.
  - ii) Constable Silvano participated in a 5 km kilt ride on June 25, and attended the annual Cottam Rotary Fall Fair and Horse show on September 18 which was well attended;
  - the Reduce Impaired Driving Everyway (RIDE) Grant Application for the 2022-23 to 2023-24 term (2-year term) has been submitted to the Ministry of the Solicitor General;



- iv) Speed trailer results--Data taken on Road 3 East resulted in an average speed of 70 km/hr. in a 60 km/hr. zone. County Road 50 speed trailer results resulted in an average speed of 52 km./hr. in a 50 km/hr. zone.
- v) A new heating and air conditioning unit has been added to Kingsville Detachment. Town of Kingsville Parks and Recreation Manager Courtney Godfrey is addressing the security lights etc.
