A. CALL TO ORDER

Mayor Rogers called the Regular Meeting to order at 6:00 p.m.

B. LAND ACKNOWLEDGEMENT

Mayor Rogers acknowledged the Three Fires Confederacy (Ojibwe, Potawatomie and Odawa) and the Traditional ancestral, unceded territory of Caldwell First Nation; the original people of Point Pelee, Pelee Island and its surrounding waters. We recognize and respect the First Nations who are stewards of the land and waters of Turtle Island and who have embraced this stewardship since time immemorial. We would like to acknowledge other nearby First Nations Communities and First Nations across Turtle Island.

D. MAYOR'S WELCOME AND REMARKS

Mayor Rogers welcomed everyone this evening and encouraged the community to attend meetings or watch from home, email questions and comments to Council, volunteer through Council committees, engage positively through Town owned media platforms and sign up for town news on the Town's website.

E. AMENDMENTS TO THE AGENDA

Deputy Mayor DeYong and Councillor Neufeld each added one announcement to the agenda during Item Q.

F. DISCLOSURE OF PECUNIARY INTEREST

Mayor Rogers reminded Council that any declaration is to be made prior to each item being discussed and to identify the nature of the conflict, if any, as the agenda items come forward.

Councillor Lowrie disclosed an interest in Items G1 and 2 and I1 indicating that through discussion with the Integrity Commissioner she was advised she has an interest as an Erie North Shore Minor Hockey member, yet it is not pecuniary in nature and will be discussing and voting on the matter.

G. DELEGATIONS

1. Ice Slab Replacement - Raedeen Chambers, Skate Kingsville

Ms. Chambers addressed Council with respect to the arena ice slab replacement. She advised that Skate Kingsville is in agreement with the slab replacement as proposed.

2. Ice Slab Replacement - Gary Toupin, Erie North Shore Minor Hockey

Mr. Toupin addressed Council with respect to the ice slab replacement. Mr. Toupin introduced Nelson Ferreira, Treasurer and Heide Mikkelsen, who would also be representing the Board this evening. Mr. Toupin advised that Erie North Shore Hockey is in support of the ice slab replacement, however is unhappy with the timing of the replacement and suggested that communication with the user groups was lacking. Mr. Ferreira addressed Council with respect to concerns of additional costs and lost revenues for Erie North Shore Hockey. Mr. Mikkelsen requested reduced fees for their membership and as much communication as possible going forward.
