C. LAND ACKNOWLEDGEMENT

Mayor Rogers acknowledged the Three Fires Confederacy (Ojibwe, Potawatomie and Odawa) and the Traditional ancestral, unceded territory of Caldwell First Nation; the original people of Point Pelee, Pelee Island and its surrounding waters. We recognize and respect the First Nations who are stewards of the land

and waters of Turtle Island and who have embraced this stewardship since time immemorial. We would also like to acknowledge all the moccasins who have walked lands of Turtle Island.

Mayor Rogers read the Call of Action for Truth and Reconciliation for Public Servants:

We call upon federal, provincial, territorial, and municipal governments to provide education to public servants on the history of Aboriginal peoples, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal—Crown relations. This will require skills based training in intercultural competency, conflict resolution, human rights, and anti-racism.

D. MOMENT OF SILENT REFLECTION AND NATIONAL ANTHEM

Mayor Rogers invited everyone to stand for a moment of silent reflection and the national anthem.

E. DISCLOSURE OF PECUNIARY INTEREST

Mayor Rogers reminded Council that any declaration is to be made prior to each item being discussed and to identify the nature of the conflict, if any, as the agenda items come forward.

G. MAYOR'S WELCOME AND REMARKS

Mayor Rogers said there were several comments and questions regarding meeting procedure following the September 11, 2023 meeting. He reminded everyone that procedure exists because everyone deserves a fair, effective and efficient order of business.

Mayor Rogers read Section 6 of the Town's Procedure By-law which sets out the rules for delegations and presentations This Section states that the Clerk may reduce the time limit allotted for speaking for each delegation as the total time limit for all delegations shall be 30 minutes. It further states that where there are numerous delegations taking the same position on a matter, delegates are encouraged to select a spokesperson to speak on behalf of the group and delegations are not permitted to assume any unused time allocated to another delegation.

He reminded everyone that Council understands that residents are passionate about their Town and items on the agenda; however, every person has the right to a respectful environment and decorum will be maintained.

1. Ontario Housing Affordability

That Council directs Administration to respond on its behalf with the following priorities and recommendations arising from the Minister's request.

- 1. Bill 23 removes Development Charges for attainable and affordable housing. This eliminates the long-standing principle that "Growth should pay for Growth". The removal of Development Charges means that growth will have to be paid by existing taxpayers, unless the province or federal government is willing to make municipalities whole for these lost charges. To make matters worse, this government has failed to clarify the definition of attainable housing throughout 2023 which leaves municipalities with uncertainty. Kingsville asks the government to clarify that development charges will only be removed as recommended in the Task Force Recommendations, which is for affordable and subsidized housing and only those which have a commitment to remain affordable for 40 years.
- 2. Although not included in the Task Force Recommendations, the provincial government has proposed changes under Bill 98 to allow closed schools to be sold to municipalities at nominal cost if the property is utilized for housing. We ask the government to sell the three Kingsville school properties to the Town for \$1 each and to trust the Town to utilize these lands for good purposes, including housing or other community and municipal needs.
- 3. Town of Kingsville requests that the province direct MPAC to implement new property valuations or assessments. The current assessments are dated and resulting in an unfair tax burden on some members of our community. Fairness should be a goal of the provincial government and this policy of deferring assessments results in unfairness.
