#### **Project Overview**

#### **Background and Project Location**

- Contract 1, from Ellis Side Road easterly to east of Essex County Road 23 (approx. 5 km of widening), was awarded to the Design-Builder, Coco Paving, in October 2020 and construction started in March 2021
- Construction is anticipated to be completed by Fall 2023
- Contract 2, from east of Essex County Road 23
   easterly to Essex County Road 34 (approx. 15.7
   km of widening), is being delivered through
   Infrastructure Ontario's (IO's) Design-Build Finance P3 model
- The contract was awarded, with a Premier's Podium announcement on June 1<sup>st</sup>, 2023




## **Project Overview**

- Widening of Highway 3 for 15.7 km to a new four lane cross section with a 15 m depressed median on the existing alignment
- Two new lanes being constructed south of the existing alignment for the Eastbound direction and rehabilitation of the existing lanes for the Westbound direction
- Improvement and widening of five (5) intersections, including two (2) existing signalized intersections and three
   (3) new signalized intersections
- Construction of several side road realignments and new side road alignments within the local network
- Drainage improvements including the extension of five (5) mainline structural culverts, replacement / relocation
  of one (1) structural culvert, replacement/extension of existing centerline culverts along with the installation of
  additional culverts for the modifications to the local road network




## **EA Consultation & Project Websites**

- Two Design and Construction Reports (DCR) are anticipated to be prepared to document the scope of work, potential impacts and mitigation measures
  - As each DCR is completed, it will be made available for a 30-day public comment period prior to the start of construction






## Essex Road 27 (Belle River Road) / South Talbot Road




