A. CALL TO ORDER

Mayor Rogers called the Regular Meeting to order at 6:09 p.m.

B. LAND ACKNOWLEDGEMENT

Mayor Rogers acknowledged the Three Fires Confederacy (Ojibwe, Potawatomie and Odawa) and the Traditional ancestral, unceded territory of Caldwell First Nation; the original people of Point Pelee, Pelee Island and its surrounding waters. We recognize and respect the First Nations who are stewards of the land and waters of Turtle Island and who have embraced this stewardship since time immemorial. We would also like to acknowledge all the moccasins who have walked lands of Turtle Island.

C. MOMENT OF SILENT REFLECTION AND NATIONAL ANTHEM

Mayor Rogers invited everyone to stand for a moment of silent reflection and the national anthem.

D. MAYOR'S WELCOME AND REMARKS

Mayor Rogers welcomed everyone to Council's second meeting at the Unico Community Centre and thanked the IT Department for their hard work in setting up the space.

Mayor Rogers said that he and several members of Council and the CAO attended the 2024 Rural Ontario Municipal Association (ROMA) Conference, held in Toronto from January 21-23. He said that the team from Kingsville worked hard to network and put Kingsville on the map throughout the Conference. Mayor Rogers said that the conference had several sessions on drinking water and wastewater infrastructure, and highlighted potential funding opportunities from

the Province. He expressed Kingsville's hope to receive funds for the future construction of a waterline that will support growth and development on the west side of Kingsville.

Mayor Rogers further noted that at the Conference, the team delegated to the Ministry of Tourism, Culture and Sport for funding to assist with the development of Mettawas Park and the expansion of the Town's recreation facilities. The team also delegated to the Ministry of Seniors and Accessibility respecting the Town's application for a Seniors Active Living Centres (SALC) grant which would be used to fund programming for seniors in the community. He said that MPP Daisy Wai, Parliamentary Assistant to the Minister for Seniors and Accessibility remembered the Town from her tour of Kingsville and its facilities. The Town hopes to hear soon whether it was successful in receiving the SALC grant.

Mayor Rogers commended the OPP for keeping the community safe in light of an incident on January 25, 2024, which saw a person successfully arrested without injury to others. He assured the public that while the incident was scary, Kingsville is a safe community.

Lastly, Mayor Rogers noted that the Windsor-Essex Regional Chamber of Commerce announced its finalists for the 2024 Business Excellence Awards. Mayor Rogers congratulated Councillor Lowrie on being a "Business Ambassador of the Year" finalist and thanked her for her dedication to the business community. He also said that other notable Kingsville individuals, Aaron Nixon of Main Street Pharmacy and Wellness Centre and Alexandrea Anber of Auntie Aldoo's Kitchen Inc., are finalists for other awards.
