1. Town of Kingsville Radar Speed Signs – Dan Baughan, Engineering Technician

Dan Baughan shared data that was recorded from one of the portable speed located on the north end of Jasperson Avenue. Over a 3-week period in December and January, the top speeds recorded were between 88-131 km/hr. This is a concern as the new school will be opening in September 2024. Dan noted that he will provide the O.P.P. with additional raw data, to summarize and share with their officers.
