## A. CALL TO ORDER

Deputy Mayor DeYong called the Regular Meeting to order at 6:00 p.m.

## B. DISCLOSURE OF PECUNIARY INTEREST & GENERAL NATURE THEREOF

The Chair reminded the Committee that any declaration is to be made prior to each item being discussed and to identify the nature of the conflict, if any, as the matter comes forward.

## C. DELEGATIONS

Larry Myers, resident, appeared as a delegation to speak to nuisances he is experiencing due as a result of the operation of Pelee Island Winery. Mr. Myers detailed nuisances related to lighting, traffic, noise and the operation of the Winery's event venue. He asked for Town By-laws to be enforced, for steps to be taken to mitigate the lighting issues, and for a fence to be built.

Lorrie Mensch, resident, appeared as a delegation to speak to Item D.1 - Short Term Rental Survey Results. Ms. Mensch noted that she owns two (2) short terms rentals. She spoke in favour of Short Term Rental ("STR") licensing and provided suggestions to the Committee on the same, including requiring a specific type of insurance.

Sandy Smith, resident, appeared as a delegation to speak to Item D.1 - Short Term Rental Survey Results. Ms. Smith spoke in favour of STR licensing and noted that she does not wish to see people buy homes in the uptown for use as STRs.

Linc Kesler, resident, appeared as a delegation to speak to Item D.1 - Short Term Rental Survey Results. Mr. Kesler spoke in favour of STR licensing so that the

Town has recourse when people are not operating an STR in accordance with established standards. He further suggested that the Committee to consider the density of existing STRs in Kingsville and suggested that an advisory committee be established to help develop any resulting regulations.

Rita Singor, resident, appeared as a delegation to speak to Item D.1 - Short Term Rental Survey Results. Mr. Singor spoke in favour of STR licensing and said she supported Mr. Kesler's suggestion to establish an advisory committee. She suggested that one of more persons from their citizen action group on STRs should be appointed to any resulting committee.

Tony Policella, resident of Cedar Island, appeared as a delegation to speak to Item D.1 - Short Term Rental Survey Results an owns STRs. Mr. Policella noted that he owns STRs and spoke to their benefits including job creation, and tourism support for local restaurants and wineries. Mr. Policella suggested that if the Town were to proceed with licensing, it should be affordable as opposed to punitive. He further suggested that licences should be transferable.

James Flynn, resident and owner at The Grove, appeared as a delegation to speak to Item D.1 - Short Term Rental Survey Results. Mr. Flynn spoke in favour of licensing STRs in the form of an annual licensing program and suggested a mill rate to further distinguish between residential and commercial settings.
