If Amherstburg is approved for the program, Fantasy of Lights committee offers the Lakeside Park Gazebo ("Gingerbread House") to be the location of the elf, on Sunday, December 8 from 10 am to 8 pm (the duration of the marketplace and Kingsville Express train rides).

• Ursa Major Day Support Program

The committee has parade route changes and chose to opt for a 'rolling barricade' at Herrington St. and Park St. This means these roads, and portion of Division St which connects them, will remain open until the parade floats turn from Main St. onto Division St.

At that time, Herrington St. and Park St will be closed to allow the parade floats safely through.

This route will be presented to council on September 28, 2024 for review.

The committee reviewed a recommendation by the Town of Kingsville's community policing officer to invest in paid-duty officers for the purpose of supervision of the parade.

iii. Paws and Claus

Pet Valu has been contacted to query if they are interested in handing out gift bags once again.

Santa Claus has been secured for this event for a total of \$150 for two hours.

iv. Christmas Artisan Market

A total of 23 vendors have committed to the Christmas Artisan Market so far.

We have the remaining room for three single-space vendors.

v. Breakfast with Santa/Crafts with Santa

The Breakfast with Santa will include sausages, pancakes, and a juice box. The committee will limit it to 65 people per hour, and 30 people must be registered for that



hour of service for that hour of food service to run. People will be offered another time slot or given a refund.
