**A. CALL TO ORDER**

Mayor Santos called the Regular Meeting to order at 7:00 p.m.

**E. PRESENTATIONS/DELEGATIONS**

**1. Fran Chartrand and Donna Murawski of the Erie Shores Quilters Guild (SEE Staff Report H-1)**

Ms. Francoise Chartrand, Erie Shores Quilters' Guild Charity Program Chairperson, and Ms. Donna Murawski, President, provided a slide presentation displaying various finished quilts made by The Charity Program of the Guild. They also showed Council a variety of finished 'lap' quilts that will be donated soon.

They indicated that thirty quilts have been donated to the Hiatus House and over forty quilts are designated for donation to the Royal Oak Nursing Home in Kingsville.

Ms. Chartrand thanked Council for allowing 4 months of rent-free space at the Unico to work on their quilts and requested that Council consider continuing allowing the waiver of the rental fee for the Unico Building once per month for the purposes of the quilt-making.

Mayor Santos thanked the members of the Guild for their work and their presentation, and then brought forward Staff Report H-1 for discussion.

Comments from Council:

Deputy Mayor Queen asked Mr. Brown to explain, in general terms, the Town's site plan approval process, and Mr. Brown provided such explanation.

Councillor Patterson asked for clarification pertaining to truck loads and load restrictions. Mr. Brown advised that, as stated within the Planning Report, there will be weigh scales located on site, and further that trucks the size of garbage trucks will be entering the facility with their loads.

Councillor Patterson questioned efforts to be made to mitigate the sound signals on the trucks. Mr. Brown indicated this site is zoned for heavy industrial use and that zoning has been in place since 1996. There are specific industrial zoning setbacks in place.

Comments from the Applicant's representative/agent:

Tom Storey, Storey Samways Planning Consultants, representing the applicant, indicated he agrees with the contents of the Planning Report presented by Mr. Brown. He pointed out that the proposed zoning will be subject to the holding symbol provision so that the waste transfer use cannot begin until the Ministry of Environment and Climate Change has completed its Environmental Compliance Approval (ECA). He stated that storm water management is more complicated because this is an orphan site and not part of a particular drain, and it will have to

be determined which way the land will drain. These and other matters will be reviewed as part of the site plan process.

Councillor Neufeld asked the Applicant to explain the potential benefits to the Town.

Mr. Mocerri replied that the proposed recycling and waste transfer station will reduce truck traffic (traffic will enter/exit one station), will provide a recycling centre with 10-12 employees onsite, and the possibility for the attraction of other business development, among other benefits. The operation will run from 7:00 a.m. to 6:00 p.m. weekdays, and 7:00 a.m. to 2:00 p.m. on Saturdays.

Comments from the audience:

Maria Araujo, 2082 Road 3 East asked for clarification as to the location of the driveway access for the trucks and stated concerned with the amount of truck traffic that the Applicant has indicated the facility is expected to generate (20-25 per day) and traffic safety.

The Applicant responded that the 2 accesses from the north side of the property would be the access points to the site and that a roadway around the back (south) of the building provides entrance into the unloading and loading areas of the facility. The trucks accessing the property are normal collection trucks and that there will only be 2 or 3 large trucks leaving the site to dump.

Maria Araujo stated that the trees in front of the proposed development are not trees, but rather brush growth, and does not represent a sufficient buffer. The Applicant stated that more buffering will be provided at the front of the property. Mayor Santos explained buffering should be addressed at the site plan process.

Maria Branco, 2014 Road 3 East, expressed concerns about the additional traffic on Road 3, that there is already existing truck traffic and the extra truck traffic will cause delays at the roundabout.

The Applicant explained all traffic will run during the daylight hours.

Allison Araujo, 2018 Road 3 East, stated concerns that the facility might create line-ups for dumping at the site.

Michael Araujo, 2068 Road 3 East, asked that his comments as contained in his correspondence dated November 10, 2017 (included with the Planning Report above) be taken into consideration for the site plan consideration meeting. He stated concerns pertaining to the monitoring of the weight of the vehicles, flooding and drainage, and finally asked Council to consider the noise from the

back-up alarms of the trucks and allow the neighbouring residents to enjoy their homes on the weekend.

Mr. Brown stated that buffering and drainage and other matters will be reviewed, and more detail will be provided through ongoing discussions.

Felice Gualdieri, indicated that he farms the property to the east of the proposed facility and asked that a commitment be made for a sufficient berm/buffer to protect the crops from any harm. He stated he is also concerned about the potential line-ups to the dumping site.

Mr. Brown confirmed that the buffer provision is included in the amending By-law.
