POLICE SERVICES BOARD MEETING Wednesday, March 29, 2017 at 4:00 p.m. Council Chambers, Municipal Offices 2021 Division Road N., Kingsville, ON N9Y 2Y9

A. CALL TO ORDER

B. DISCLOSURE OF PECUNIARY INTEREST

Chairperson, Nelson Santos reminded members that any declaration and its general nature are to be made prior to each item being discussed.

C. PRESENTATIONS/DELEGATIONS

Constable Gord Keen from the Orillia O.P.P detachment was in attendance to present a power point on off road vehicles and the provincial traffic program.

Constable Keen is an expert on this issue with the O.P.P and the *Provincial Highway Traffic Act*, specifically with regulation 316/03 involving off road vehicles. Municipalities must look to how the Province defines these vehicles in the definitions section of the Act, and to address enforcement of using these vehicles on sidewalks and roadways. There are three (3) types of vehicles: Recreational off – highway vehicles (ORV), All Terrain Vehicles (ATV), and Utility Task Vehicle (UTV). There is no license to drive these vehicles under this regulation; however, if this type of vehicle is driven on a municipal road, the driver must have their Ontario driver's license. Young people under the age of 18 years are permitted on these vehicles. There are no restrictions to age in the Highway Traffic Act. Research has indicated that there has been serval collisions and injuries reported to the O.P.P. involving off road vehicles.

Constable Keen recommended the following to Council and the Board:

- a.) that Council should determine and evaluate the reasons (tourism, economic development, etc...) to implement this bylaw;
- b.) there should be plenty of opportunity for public feedback for the bylaw proposal and education on the vehicles, specifically on what types of vehicles allowed, licensing and safety requirements;
- c.) Council chooses, the Town could move forward with a small pilot project involving off road vehicles and evaluate the project once completed.

Discussion

L. Patterson thanked the Constable Keen for his presentation and vast expertise on the issue of ATV's. If Council were to proceed with creating a by-law for allowing these types of vehicles in our area, there will be considerable discussions with multi-level government organizations and public input. The Town of Lakeshore and Chatham–Kent have pilot programs. If Council decides to proceed, we should contact these municipalities for remarks on their experience.

S/Sgt. Bertram indicated that an off road vehicle by-law would have its challenges with enforcement. There would need to be training sessions for all O.P.P. officers to enforce this by-law.
