Take notice that Decisions from the sitting of the 2<sup>nd</sup> and 3<sup>rd</sup> Sitting of Court of Revision have resulted in changes to the Schedule of Assessment dated June 17, 2016. It has been brought to our attention that the County of Essex was not included in the circulations advising of these changes. As a result and in accordance with the *Drainage Act*, we are providing you with notice that your assessment was impacted by the decisions of the court and will have the opportunity to appeal these decisions on **Monday, May 14<sup>th</sup>, 2018**.

A copy of the revised Schedule of Assessment dated March 2<sup>nd</sup>, 2018 has been enclosed for your review. As a result of the 3<sup>rd</sup> Sitting of the Court of Revision on April 3<sup>rd</sup>, 2018 an **additional \$6,327.85** will be added to your assessment which is not reflected in the attached.

Pursuant to section 52(1) of the *Drainage Act*, objections or appeals to the assessment must be forwarded in writing, to the **attention of the Clerk**, at least ten (10) days prior to the date of the Court of Revision.
